2. A \$5.00 check or money order made payable to the Kansas Department of Revenue should be included by the filing agent submitting this form.
3. The affidavit section must be completed and all vehicle information verified prior to filing.
4. Private Individual Filing Lien additionally must submit:
  1. Verification of last registered owner. (Obtained by submitting written request, along with \$1.00 fee, to the Kansas Department of Revenue, Title and Registration Bureau, Topeka, Kansas 66626-0001.)
  2. Copy of child support document obtained from District Court.
